In accordance with Article 28 of the Law on Consumer Protection, the consumer has the right to withdraw from the Contract concluded at a distance, ie outside the business premises within 14 days from the day when the goods arrived in the consumer's country and from the day when the withdrawal form was submitted. . Upon receipt of the form for unilateral termination of the contract, the trader will without delay notify the buyer of the receipt of the form, and give him instructions for the return of goods.

Pursuant to Article 35 of the Law on Consumer Protection, the consumer is obliged to return the goods to the trader without delay, and no later than within 14 days from when he sent the withdrawal form. The

goods will be considered returned within the deadline if the consumer sent the goods before the expiration of the period of 14 days from the day when he sent the withdrawal form. The consumer bears only the direct costs of returning the goods. The consumer can return the goods by courier, mail or return them in person.

By signing this form, the consumer in accordance with the Consumer Protection Act declares and confirms that:

- agrees to a refund when the goods are returned to the trader at the address for receipt of goods and the withdrawal form.
- that the trader may deny a refund of the entire purchase price or reduce the value of the purchase price proportionally if he finds that the goods are not in good condition and that the cause of the defect is inadequate or improper handling by the consumer
- that he is solely responsible for the impaired value of the goods resulting from the handling of the goods in a way that is not adequate, ie exceeds what is necessary to establish the nature, characteristics and functionality of the goods.

NUT d.o.o. will use the personal data of the Consumer from this form only for the purpose of changing the recording of trade in goods and will never use them in any other way, nor will they give them to third parties.
